This is to inform you that Boxing Federation of India is planning to hold Selection Trials for Youth Men & Women at National Boxing Academy (NBA), Rohtak, Haryana from 27th to 29th January, 2020 to select the Boxers for upcoming National Boxing Coaching Camps for foreign exposures.

Eligibility for Youth Women

1. The Boxers of age group of 2002-2003 (i.e. born between from 01st January, 2002 to 31st December, 2003) only are eligible.
2. Medal winner of the Khelo India Youth Games-2020 held at Guwahati will directly selected for the Selection Trials at NBA, Rohtak.
3. Boxers who attended last National Boxing Coaching Camp for Youth Women at SAI, NBA, Rohtak from 10th Dec., 2019 to 13th Jan., 2020 but not selected for 3rd

Khelo India Youth Games-2020 are also eligible to attend the said Selection Trials. The names of these Boxers are :-

4. Top four teams (State/Board) of last Youth Women National Boxing Championships held at Rudrapur, Uttarakhand from 08-14 June, 2019 i.e. Haryana, Rajasthan,

Punjab and Manipur can nominate 04 (four) Boxers.

5. Other State / UT / Boards can nominate a maximum of 2 Boxers from any of the 10 weight categories for the above said selection Trails.

6. The Selected Boxer(s) will join the National Boxing Coaching Camp for Youth Women. The dates will be informed later on subject to the approval by SAI.

Eligibility for Youth Men

1. The Boxers of age group of 2002-2003 (i.e. born between from 01st January, 2002 to 31st December, 2003) only are eligible.

2. Medal winner of the Khelo India Youth Games-2020 held at Guwahati will directly selected for the Selection Trials at NBA, Rohtak.

3. Boxers who attended last National Boxing Coaching Camp for Youth Men at SAI, Bhopal from 15th June to 29th October, 2019 but not selected for 3rd Khelo India

Youth Games-2020 are also eligible to attend the said Selection Trials. The names of these Boxers are :-

1. Mr. Bhupesh Rahul – 69 Kgs. (DEL)
2. Mr. Ashok Sai - 69 Kgs. (SSCB)

4. Top four teams (State/Board) of last Youth Men National Boxing Championships held at Rudrapur, Uttarakhand from 08-14 June, 2019 i.e. Services, Haryana, Delhi

& Uttar Pradesh can nominate 04 (four) Boxers.

5. Other State / UT / Boards can nominate a maximum of 2 Boxers from any of the 10 weight categories for the above said selection Trails.

6. The Selected Boxer(s) will join the National Boxing Coaching Camp / Academy for Youth Men at NBA, Rohtak, Haryana from 01st February, 2020 subject to the approval by SAI.

The boarding/lodging, local transportation in Rohtak on 27th to 29th January, 2020 as well as To and Fro transportation from respective place to Rohtak and back will be the responsibility of State/UT/Board/Individual.

The Boxer(s) who are coming for Selection Trials must bring following documents in original along with him/her :-

1. Aadhaar Card
2. Bank Passbook
3. Birth Certificate issued by their State Govt.
4. Age Estimation Test Report (if done before)
5. Passport which is valid at least 06 months from 1st Feb., 2020.

Your nomination must be on letter head with signature and stamp of the President / Secretary of the Association / Board.
