This is to inform you that Boxing Federation of India is planning to hold Selection Trials for Elite Women at I.G. Stadium, New Delhi from 13th to 15th March, 2020 to select the fresh talent, reshuffle/prune down the existing strength of the boxers for National Boxing Coaching Camps for Elite Women at I.G. Stadium, New Delhi.

- 1. The National camp Boxers other than Ranking 1 & 2 (except 81 Kgs.) will participate. All Boxers in 81 Kgs. weight category will participate in the said Selection Trials.
- 2. The Medal Winner Boxers of last ASBC Asian Youth Women's Boxing Championships held at Ulaanbaatar, Mongolia from 08-18 November, 2019 and now turned Elite are also invited to attend the above said Selection Trails.
- 3. Gold and Silver medallist from Khelo India Youth (U-21) Games held at Guwahati from 09-22 January, 2020 are also invited for the above said Trials.
- 4. Gold and Silver medallist from Khelo India University Games to be held at Bhubaneshwar, Odisha from 25th Feb. to 01st March, 2020 are also invited for the above said Trials.
- 5. Top four teams (State/Board) of last Elite Women's National Boxing Championships held at Kannur, Kerala from 02-08 December, 2019 i.e. Railways, Haryana All India Police and Uttar Pradesh can nominate 06 Boxers.
- 6. The winner (Gold) of Zonal Championships held during the 2019-2020 are also eligible.
- 7. Other State / UT / Boards can nominate a maximum of 2 Boxers from any of the 10 weight categories for the above said selection Trails.

The boarding/lodging as well as To and Fro transportation from respective place to Delhi and back will be the responsibility of State/UT/Board/Individual.
