I have gone through the list forwarded by the States as well as Model Election Guidelines to be followed by all National Sports Federations framed by Govt. of India National Sports Development Code of India, 2011, Ministry of Youth Affairs and Sports Department of Sports.

My recommendation as Returning Officer given below: -

West Bengal

- So far as name of authorised representative sent in Form 1 of the West Bengal there is no contradiction between the Secretary and the President in the name of Mr. Asit Benerjee. I recommend Mr. Asit Benerjee is recommended as authorised representative.
- So far as Sr. No. 61 and 62 are concerned names amongst Mr. Swapan Benerjee and Mr. Indrajit Sen, Mr. Swapan Benerjee is a representative of the Secretary himself whereas the President has recommended Mr. Indrajit Sen. Obviously Mr. Swapan Benerjee being the Secretary at present seems to be a good choice to be authorized representative for the elections therefore I recommend the nominee of the Secretary Mr. Swapan Benerjee as authorised representative.

- c) Similarly for TN since Mr. S. Mohan as authorised representative, he is continuing as General Secretary therefore the recommendation in his favour for the authorized representative of the Boxing Federation of India in accordance with Form 1 is recommended as authorised representative.
- d) There is no dispute about the Nominee of the President Mr. Pon Bhaskaran therefore the recommendation in his favour for the authorized representative of the Boxing Federation of India in accordance with Form 1 required to be informed.

Dadra and Nagar Haveli and Daman and Diu

- e) So far as Dadra and Nagar Haveli and Daman and Diu are concerned on 24th January 2020 the Ministry of Law and Justice have amalgamated both the Union Territory and has passed the order to the following effect: -
 - "1(I) This Regulations may called the Union Territory of Dadra and Nagar Havli and Daman and Diu Goods and Services Tax (Amendment) Regulation 2020.*
 - (2) It shall come into force on the 26th day of January 2020.*
 - 2. In the Union Territory Goods and Services Tax Act, 2017 (hereinafter referred to as the principal Act), in section 1, sub-section (2), for the words "Dadra and Nagar Haveli, Daman and Diu", the words "Dadra and Nagar Haveli and Daman Diu" shall substituted."*
- f) In view of the above let one representative of each UT be taken to be authorized representative i.e. Serial no. 67 and 69.
- g) Since one representative each has to be taken into consideration I recommend the name of Mr. Rajesh Desai and Mr. Amarjit Singh as authorised representative.

The aforesaid recommendations have been given on the basis of a circular of Government of India where clause 3.10 of Annexure 2, 3.10 has given to the following effect: -

"At the National level, there will be only one recognized federation each discipline of sport. Only the duly recognized National Sports Federation would be entitled to financial grants as admissible. Only one State/UT Association from each State/UT shall be admitted as a member of the Federation, provided it has a minimum of 50% of the District level Associations affiliated to it. Any organizations of an all Indian standing and connected with the Sport may also be given the status as that of a State or that of a U.T. and admitted as affiliated Member. Other categories of membership may also be given,



but while each affiliated State/UT Unit shall have a right to cast vote in the General Body Meetings, no other class of Member(s) shall have any right to vote, in the Federation's meeting. While granting recognition/affirmation to a State/UT Association, the National Federation should take into consideration the representative character of the State/UT Association so as to ensure that only truly representative body of the game gets the recognition/affirmation."


