

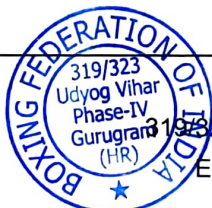

@ Nagaland Amateur Boxing Association [NABA]

The names of the representatives from the members were called for between 13.01.2021- 18.01.2021. However, Nagaland Amateur Boxing Association, through its President/ Secretary had sent names of its representatives for AGM/Elections vide email dated 12.01.2021, which was sent again on 18.1.2021.



Nagaland Amateur Boxing Association through its President, Mr. T. Meren Paul, has also sent a representation on 18.01.2021 in this regard. It is specifically stated by Mr. Paul that he was unsure of the internet in Nagaland and therefore he sent the names in advance in the prescribed format. I have gone through the representation sent by the Nagaland Amateur Boxing Association.

The Memorandum of Association and Rules & Regulations of Boxing Federation of India under Article T. Elections iii (d), allows President, BFI to accept the names of the representatives of a member unit even after the last date and time for submission of such names.

It is an admitted position that the Nagaland Amateur Boxing Association has already sent the names of their representatives on 12.01.2021 which was sent again on 18.01.2021 (after the time prescribed).

In these circumstances and the interest of larger participation in the elections of the BFI and also considering the powers as per the Memorandum of Association and Rules & Regulations of Boxing Federation of India, I allow to accept the names of the representatives of NABA.

Dadra and Nagar Haveli and Daman and Diu

Dadar and Nagar Haveli and Daman and Diu were two separate Union Territories prior to 2020. However, by the virtue of The Dadra and Nagar Haveli and Daman and Diu (Merger of Union Territories) Act, 2019 notified on 9th December, 2019 read with Government of India notification dated 19th December, 2019 [S.O. 4542 (E) & S.O. 4543 (E)], Government of India proclaimed the two UTs as one.

As per the Memorandum of Association and Rules & Regulations of Boxing Federation of India, 'each member Association shall have 2 (two) votes at the elections'. Further, Memorandum of Association and Rules & Regulations of Boxing Federation of India further stipulate that 'Only one association shall represent a State/UT/Board' and as per the provisions of the National Sports Development Code, 2011 provides that 'Each permanent Member State/Union Territory duly affiliated by the Federation as its permanent Member shall have two votes at the elections of the Office Bearers and Managing Committee Members'.

Therefore, I as the President consider it as a fit case where 1 (One) representative each of both the Associations, i.e., Dadra & Nagar Haveli (UT) Boxing Association and Daman & Diu Boxing Association be allowed to represent. I therefore allow the names of first representative of both Dadra & Nagar Haveli (UT) Boxing Association and Daman & Diu Boxing Association to be included in the Form -I. This is also in line with the previous decision of the Returning Officer on this issue.

* **Bengal Amateur Boxing Federation [BABF]**

Boxing Federation of India has received two lists of representatives from Bengal Amateur Boxing Federation; one from the President and another from the Secretary General. The list sent by the President, Bengal Amateur Boxing Federation, includes the names of President - Asit Banerjee and Indrajit Sen – Secretary. A representation has also been received from the Secretary General of Bengal Amateur Boxing Federation in this regard. After considering the representation of the Secretary General Bengal Amateur Boxing Federation and the BFI records, I am not inclined to




include the name of Mr. Indrajit Sen in the Form-1 sent by the President, Bengal Amateur Boxing Federation on the following grounds: -

- i. Mr. Indrajit Sen, whose name is sent by the President along with his own name, continues to represent himself as the Treasurer of the Indian Amateur Boxing Federation [IABF], and therefore cannot be part of the member association of BFI member unit.
- ii. Mr. Indrajit Sen, by continuing to be the part of IABF, derognised by Ministry of Youth Affairs & Sports vide their letter no.F.19-10/2012-SP.III dated 28th March, 2014, is indulging in anti-federation activity and therefore cannot be allowed to be the part of the BFI.
- iii. As per the BFI records, Mr. Indrajit Sen has not attended any AGM of Boxing Federation of India being the representative of Bengal Amateur Boxing Association and all the meetings have been attended by Mr. Asit Banerjee and Mr. Swapan Banerjee.
- iv. Mr. Indrajit Sen resigned from the Bengal Amateur Boxing Federation in 2014.

Since the name of Mr. Indrajit Sen sent by the President Bengal Amateur Boxing Federation, cannot be included in Form-1, in view of the above reasons, I have to consider the list of names sent by the Secretary General of Bengal Amateur Boxing Federation for the second representative.

I find that the names sent by the Secretary General Bengal Amateur Boxing Federation includes the names of Mr. Asit Banerjee, President and his own name i.e, Sh. Swapan Banerjee, Secretary General. Name of Mr. Asit Banerjee is the common name in both the lists.

In the interest of keeping the representation of the state of West Bengal in Boxing Federation of India AGM/ Elections, I accept the names of Mr. Asit Banerjee and Mr. Swapan Banerjee in Form -I.
