ADMINISTRATIVE SANCTION NO. (208/2017)

DISCIPLINE & CATEGORY :- Boxing(Youth Women)

The Administrative sanction of the Competent Authority hereby conveyed for conduct of Indian Youth Women's National Boxing Camps with 25 Boxers + 6 Coaches + 3 Supporting Staff from 20th December, 2017 to 08th January, 2018 at SAI NBA Rohtak for preparation of 7th Nations Cup International Boxing Tournament Scheduled to be held at Sombor, Serbia from 09-15 January, 2018. The terms & Conditions as follows:-

1. Boarding & Supplementary-
 - a) Rs.. 450/- Boarding per day per head for players).
 - b) Rs. 550/- supplements per day per head for players to be provided by BFI on reimbursement basis from SAI).
 - b) Rs. 450 Boarding only per day per head coaches and supporting staff.
2. Lodging up-to Rs.900/- per day per head for campers to be booked at SAI Head Quarter.
3. Rs.300/- Overhead charges per day per head.
4. FOP 10,000/- per day to booked at SAI HQ.
5. Travel as per revised MYAS norms.
6. Medical on actual.
7. Please ensure that the guidelines issued by TEAMS Division for holding of National Coaching Camp is adhered to.
8. SAI coaches deputed with this camp may also be relived as per SAI norms subject to consent from concerned regional centre
9. BFI has sub,itted that Boxers proposed for this camp are well within eligible age as they were part of camp from before also & will come along with valid DOB certificate. However SAI would conduct Age estimation test for any suspicious case.
10. BFI to provide Food supplements for the camp as per laid down norms. It may be advanced or may be reimbursed basis
8. List of campers, coaches and supporting staff reported for the camp should be forwarded to TEAMS Division of the 3rd day from the commencement of the camp.
9. Bio data of each camper may be sent on a prescribed Performa
10. On conclusion of the National Coaching Camp, Chief Coach in charge shall submit a Comprehensive report of coaching camp including performance of Asstt. Coaches, supporting staff through Regional Head within 15 days to the TEAMS Division.
11. It is mandatory for the Regional Head/Centre and the concerned Federation to submit Monthly expenditure statement on last working day of the month and Utilization Certificate within 15 days of completion of the camp to the Finance Division with copy to TEAMS Division.
12. The expenditure may be debited to under the Head "General Assistance for holding Coaching Camp (Code No. 49.0500).
13. The monitoring of attendance on daily basis shall be maintained.
14. Issued Equipment to be verified & stock entered in to register.
15. Scientific Support shall also be extended to the camper on request.
16. List of the campers & camp days is attached herewith.
17. Sports Kit to be issue once a year as per guidelines.

18. All age category camps (Sub Junior(Juniors) ,Junior(Youth) will commence only after age of players are verified as per the Age Certification test as approved by MYAS. Players, fall within the age range only, will be permitted to attend the camp. However, if the Regional head SAI feels about some discrepancy in the age of any camper, he or she may be directed to go for age verification test from the hospitals which have been notified by SAI, HQ, in consultation with The coach In-charge.
