No. 6/1/85-Estt. (Pay-I) dated 30.1.1989. The Federation should inform their employing Department/Office accordingly.

7. Selected SAI coach **Mr. Khima Nand Belwal SAI Assistant Coach Boxing**, posted at SAI STC Mastuana Sahib, District Sangrur-148 002 (PUNJAB) will proceed for above Asian Championship at Bangkok after obtaining vigilance clearance and NOC from SAI, Head Office.
