Eligibility

:

Boxers born during the year January 1, 2006 - December 31, 2007) are eligible. Entries will be accepted on receipt of Entry by Number & Entry by Name as per the enclosed format send by the District Association <u>duly endorsed by the President/Secretary of the respective States affiliated with Boxing Federation of India.</u>

All Boxers must have their <u>Original Birth Certificate</u>, <u>School joining as well as current School Certificate</u>, <u>Aadhar Card & Medical Book</u> endorsed by the respective State Association. Photocopy of the original Birth Certificate must be produced at the time of initial weigh-in and Medical Examination. All boxers <u>must comply before Registration</u>, with Age Verification Test Reports as per **NCAFS** norms and formats.

Medical & Weigh-in

Daily weigh-in and medical examination will be held at the venue daily from 07.00 - 08.00 am ONLY for the boxers drawn to box on those respective days from 16th March to 22nd March, 2020.

Draw

Draw will be held on 15th March, 2020 at 6:00 pm.

Team officials

The participating teams are entitled to bring one (1) coach for upto 6 boxers, two (2) coaches for upto 10 boxers, three (3) coaches for above 10 boxers.

Dress

Competitors shall Box in Boxing shoes or Shoes minus spikes and without heel, Shorts/skirts not exceeding knee length and a Vest covering the chest and back. Boxers shall wear a Red & Blue Vest depending on the colour of the Corner. Where vests and Shorts are of the same colour, the Belt line must be clearly indicated by using an elastic waistband 10 Cm wide of different shade.

Boarding/Lodging

Free Lodging & Boarding will be provided to all boxers and officials by the BFI from 15th March, 2020 till noon of 23rd March, 2020. The Boxer who lose their bout will have to vacate the place of lodging and will not be entitled to get boarding also.

Important

- 1. The Boxers and Officials are entitled to Railway Concession orders which will be sent through Courier / Speed Post to respective State Associations.
- 2. To and Fro cost of travel to Rohtak and back of the Team / Officials will be the responsibility of respective units.
- 3. The Team / Officials shall not arrive at venue earlier than the 15th March, 2020 and shall leave by 23rd March, 2020 by noon
- 4. All boxers must possess their own Gum shield (not of red or partially red color) Cup protector, Red & Blue Vest & Shorts / skirts according to their respective corner allocation. Pubic Protector and Breast Protector may be worn by women boxers if needed.
- 5. For the initial Weigh-in, the Boxer's weight should not exceed the maximum of the Boxer's weight class nor be below the minimum of the Boxer's weight class. However, for daily Weigh-in Boxer need to maintain his weight so as not to exceed upper limit of weight class.
- 6. No type of body piercing and body accessories is allowed to be worn during the bout as well as during Medical Examination & Weighing In.
- Boxers must carry their State Medical Record Book. They should also carry their original Municipal Birth Certificate | School Joining Certificate (SLC) | Original copy of Age verified by the Current School on their letter head for Boxing Federation of India's registration purpose, along with their Aadhar Card.
- 8. "Age Estimation Certificate" for all participating Boxers conducted at a Government Hospital as per SAI norms is needed to be submitted during Medicals.
- 9. All boxers must carry a recent Hepatitis B, C and HIV test certificate.
- 10. All participating Boxers also need to submit Annual Medical Fitness Certificate as per AIBA.
- 11. The Organizing Committee will provide Boxing gloves and Head Guards to all the Boxers for their respective bouts. Hand Bandages will be provided as well.
- 12. Adherence of strict discipline will be observed at the place of boarding/lodging and at the venue. Any breach of discipline will result in withdrawal of boarding and lodging arrangements, followed by disciplinary action.
- 13. The Championship will be conducted as per AIBA / BFI AOB Competition and Technical Rules.
- 14. Borrowing of boxers from any other unit is strictly prohibited.
- 15. Persons accompanying the team as Manager and / or Coach will not be permitted to officiate as TO / RJ in the championship.
- 16. In case of extra member in a team, a charge of Rs. 2,000/- per day /per head will be levied.
- 17. All Entries have to be <u>ENDORSED</u> by the respective <u>State Association</u> and the same has to be uploaded on the <u>BFI Portal</u>.
- 18. NO ENTRY WILL BE ENTERTAINED AFTER LAST DATES OF ENTRIES.
