Election for executive council of the Boxing Federation of India.

As per the election programme, the nomination papers were to be filed on 14th and 15th September, 2016 between 11 a.m. to 5 p.m. Today, the nomination papers which have been filed within the time allowed by the election programme are to be scrutinized.

1. President

So far as the election for the post of President for the Boxing Federation of India (hereinafter referred to as "Federation") is concerned, there is only one post of President. Within the time allowed as mentioned above, nomination papers of four persons for the post of President have been received. They are:

(i) Mr. Rakesh Thakran (ii) Mr. Rohit Jainendra Jain; (iii) Mr. Rajesh Bhandari and (iv) Mr. Ajay Singh. The names of all the four candidates, whose nomination papers have been received, are entered in the final list of voters which was published on 13th September, 2016.

As per the election programme, objections to the nomination papers, were to be filed between 11 a.m. and 5 p.m. on 16th September, 2016. No objections to any of the four nomination papers referred to above have been received. I have scrutinized the nomination papers, they appear to be in order. All the four nomination papers are accepted and endorsement to that effect has been made on the nomination papers.

2. Secretary General:

So far as the post of Secretary General of the Federation is concerned, like President, there is only one post of Secretary General. Within the time allowed by the election programme, nomination papers, nominating following persons for the post of Secretary General have been received: They are- (i) Dr. Nirmolak Singh; (ii) Mr. Jay Kowli; (iii) Mr. Lenny "D' Gama; (iv) Mr. Rakesh Thakran. The names of all the four candidates are in the final list of voters. Within the time allowed for raising objections to the nomination papers, no objections have been received to any of the nomination papers. I have examined the nomination papers, they appear to be in order. All the

nomination papers are accepted and an endorsement to that effect has been made on each nomination paper.

3. Treasurer:

So far as the post of Treasurer is concerned, there is only one post of Treasurer. Within the time allowed by the election programme, there are two nomination papers received, nominating following two candidates-(i) Mr. Hemant Kumar Kalita and (ii) Mr. Pon. Bhaskaran. There are two objections received to the nomination papers. An objection has been raised by Mr. Pon Bhaskaran to the nomination of Mr. Kalita on the ground that the Association, of which Mr. Kalita is Secretary, has not held election to the Managing Committee of that Association for number of years. But it is not disputed that the name of Mr. Kalita is included in the final list of voters which is finalized for this election on 13th September, 2016. As the name of Mr. Kalita is included in the final list of voters, he is entitled to file nomination papers and therefore, his nomination cannot be rejected. The objection raised by Mr. Pon Bhasakaran is rejected. It was pointed out to me that the copy of objection raised by Mr. Pon Bhaskaran was not served on Mr. Kalita.

Mr. Kalita has also raised an objection to the nomination of Mr. Pon Bhaskaran on the ground that the inclusion of the name of Tamil Nadu Association in the final list of voters is not proper on the ground that the papers of that Association were received by the Federation at 5.01 p.m. on 12th September, 2016, when they should have received at 5 p.m. I had considered this aspect and considering the stand taken by the Tamil Nadu Association that they had made an attempt to send their papers well within time, but due to technical fault of the machine, the papers could not be transmitted to the Federation before 5 p.m. on 12th September, 2016. As per the law settled by the Supreme Court of India and considering the aims and objects of the Federation and to permit one more association to participate, the Returning Officer has permitted the name of Tamil Nadu Association, of which Pon Bhaskaran is the nominee/representative, to be included in the final list of voters. As the name of Pon Bhaskaran as representative of the Tamil Nadu Association is included in the final list of

voters, he is entitled to file his nomination paper for the post of Treasurer. Therefore, I reject the objection raised to the nomination of Mr. Pon Bhaskaran by Mr. Kalita. Consequently, both the nomination papers are found to be valid and are accepted and an endorsement to that effect is made on the nomination papers of both the candidates.

- 4. So far as the post of Vice President, East Zone is concerned, the post is one. There are three nomination papers received within the time allowed, nominating following persons. They are, Mr. Swapan Banerjee and Mr. John Kharshingh. The names of both the candidates are in the final list of voters. There are no objections received to the nomination papers of both these candidates. I have examined the nomination papers, they appear to be in order. Nomination papers of both the candidates are accepted and an endorsement to that effect has been made on the nomination papers.
 - 5. So far as the post of Vice President for North East Zone is concerned, there is only one nomination paper received. Mr. Khoibi Salam is the candidate. The name of Mr. Khoibi is included in the final list of voters, there are no objections

received within the time allowed to the nomination of Mr. Khoibi. Hence, his nomination is accepted and endorsement to that effect is made on the nomination paper.

- 6. So far as the post of Vice President for South East Zone is concerned, there is one post. There is one nomination paper received of Mr. Anil Kumar Bohidar. His name is included in the final list of voters. There are no objections received and therefore, his nomination paper is accepted and an endorsement to that effect is made on the nomination papers.
- 7. So far as the post of Vice President for South Zone is concerned, there is only one post. There is one nomination paper of Dr. C.B. Raje is received. His name is entered in the final list of voters, there are no objections received. Hence, his nomination is accepted and an endorsement is made to that effect on the nomination paper.
- 8. So far as the post of Vice President for West Zone is concerned, there is only one post. There are two nomination papers received, nominating Mr. Amarjit Singh and Mr. Lenny 'D' Gama. Name of both the persons are in the final

list of voters. No objections received to their nomination, hence both the nominations are accepted and an endorsement to that affect is made on the nomination papers.

- 9. So far as the Vice President for North West Zone is concerned, there is only one post. There is only one nomination paper, nominating Mr. Narendra Kumar Nirwan. His name is included in the final list of voters. There is no objection received to his nomination, hence, his nomination is accepted and an endorsement is made to that effect on the nomination paper.
- 10. So far as Vice President North Zone is concerned, there is only post. Nomination papers, nominating Mr. Rajesh Bhandari and Dr. C.K. Jerath have been received. Name of both the candidates are in the final voters list. There are no objections to their nomination received. Hence, their nomination papers are accepted and an endorsement to that is made on the nomination papers.
 - 11. So far as the post of Vice President for Central Zone is concerned, there is only one post. There is only one

nomination paper nominating Mr. Anil Kumar Bohidar received. His name is included in the final list of voters. There are no objections received to his nomination, hence, his nomination paper is accepted and an endorsement is made to that effect on the nomination paper.

- 12. So far as the post of Zonal Secretary East is concerned, there is only one post. Nomination papers, nominating Mr. John Kharsingh and Mr.Swapan Banerjee have been received. Name of both the candidates are entered in the final list of voters. No objection received to their nomination. Hence, their nomination papers are accepted and an endorsement to that effect is made on the nomination papers.
- 13. So far as Zonal Secretary for South East Zone is concerned, there is only one post. One nomination paper of Mr. G.V. Ravi Raju has been received. His name is entered in the final list of voters. There are no objections received to his nomination. Hence, his nomination paper is accepted and an endorsement to that effect is made on the nomination papers.

- 14. So far as Zonal Secretary for South Zone is concerned, there is only one post. Only one nomination paper nominating Mr. R. Gopu is received. His name is included in the final list of voters. There are no objections received to his nomination. Hence, his nomination is accepted and an endorsement is made to that effect on the nomination paper.
 - 15. So far as the post of Zonal Secretary for West Zone is concerned, there is only one post. Two nomination papers nominating Mr. Rajesh Desai and Ms. Preeti Baria, whose names are entered in the final list of voters. No objection received to their nominations. Hence, their nominations are accepted and an endorsement is made to that effect on the nomination paper.
 - 16. So far as Zonal Secretary for North West Zone is concerned, there is only one post. Two nomination papers nominating Mr. Digvijay Singh and Mr. Rajesh Tokas have been received. Name of both the candidates are entered in the final list of voters. No objections to their nominations are received. Hence, both the nomination papers are accepted and an endorsement to that effect is made on the nomination papers.

- 17. So far as Zonal Secretary for North Zone is concerned, there is only one post. Two nomination papers nominating Mr. Santosh Kumar Dutta and Dr. Nirmolak Singh have been received. Their names are entered in the final list. No objections received to their nominations, hence, their nomination papers are accepted and an endorsement to that effect is made on the nomination papers.
- 18. So far as Zonal Secretary for Central Zone is concerned, there is only one post. Nomination paper of Mr. Rajiv Kumar Sing has been received, whose name is included in the final list of voters. No objection is received to his nomination. His nomination paper is accepted and an endorsement to that effect is made on his nomination paper.
- 19. Apart from the above nomination papers, four nomination papers have been received. One nomination paper nominating Mr. Kalikanta Bora does not mention the post for which the nomination paper is filed. Because the nomination paper mentions only "for election as Zonal Vice President", but the name of the zone is not mentioned. In this view of

the matter therefore, the nomination paper cannot be accepted and it stands rejected and endorsement to that effect is made on the nomination paper. The next nomination paper nominates Dr. Roopak Debroi. But, this nomination paper also merely says "for election as Zonal Vice President" but does not mention the name of the zone. Therefore, this nomination paper is also incomplete hence, cannot be accepted and consequently rejected and an endorsement to that effect is made on the nomination paper.

Jaslal Pradhan. Here also, the nomination paper mentions only "for the post of Vice President", but no name of the zone is mentioned. Hence, this nomination paper cannot be accepted. Consequently, rejected and an endorsement to that effect is made on the nomination paper. The last nomination paper nominates Mr. Lal Dhama. But this nomination paper is also incomplete inasmuch as it mentions only "for election as Zonal Secretaries. The name of the zone is not mentioned. Hence, this nomination paper cannot be

accepted and consequently it is rejected and an endorsement to that effect is made on the nomination paper.

- 21. The nomination papers as indicated above for various posts are accepted and four nomination papers are rejected mainly because they are incomplete.
- At the time of scrutiny, Mr. Kishen Narsi, Chairman, AIBA Ad-hoc Committee and Interim President, BFI, Mr. Asit Banerjiee, President, Bengal Boxing Federation. Mr. Jay Kowli, President Maharashtra Boxing Association, Mr. John Kharshiing, President Meghalaya Boxing Association, Mr. Karunakaran, Representative Tamil Nadu BA and Mr. Moksh Gujrani, Representative of Delhi ABA were present.
- 23. List of validly nominated candidates is to be published today as per the election programme.

- 2. As per the election programme, nomination papers could be withdrawn on 18th and 19th of September, 2016.
- 3. For the post of President, four nomination papers were found to be valid. Out of the four persons nominated, two personsviz.

 Mr. Rajesh Bhandari and (ii) Mr. RakeshThakran have withdrawn their nomination papers. Thus, for one post of President, there are two candidates left in the field viz. (i) Mr.

Ajay Singh and (ii) Mr. RohitJainendra Jain. Thus, it will be necessary to hold ballot for the post of President on the scheduled date i.e. 25th September, 2016.

- 4. So far as the post of SecretaryGeneral is concerned, the post is one. Four nomination papers were found to be valid. Out of the four validly nominated candidates, Dr. Nirmolak Singh has withdrawn his nomination papers. Thus, three candidates are left in the field contesting for the postof Secretary General, they are: (i) Mr. Jay Kowli, (ii) Mr. Rajesh Thakran and (iii) Mr. Lenny D Gama. As there are three candidates left in the field, polling will have to be held for the post of Secretary General on the scheduled date i.e. 25th September, 2016.
- 5. So far as the post of Treasurer is concerned, there is one post.

 Two nomination papers were found to be valid. Out of the two validly nominated candidates, Mr. PonBhaskaran has withdrawn his nomination paper. Thus, only one candidate, Mr. Hemanta Kumar Kalita, is left in the field for the post of Treasurer. Mr. Kalita is therefore, declared as elected unopposed to the post of Treasurer.

- 6. So far as the post Vice President East Zone is concerned, there is one post. Two nomination papers were found to be valid. Out of the two validly nominated candidates, Mr.SwapanBanerje has withdrawn his nomination paper, leaving only Mr. John Kharshiingas the only candidate for the post of Vice President East Zone. As there is only one candidate left in the field, Mr. John Kharshiing is declared elected as Vice President East Zone unopposed.
- 7. So far as the post of Vice President, North East Zone is concerned, there is one post. Only one nomination paper is found to be valid and therefore, Mr. Khoibi Salam Singh, being the only candidate, is declared elected unopposed as Vice president North East Zone.
- 8. So far as the post of Vice President South East Zone and Vice President South Zone are concerned, the situation is same as above and therefore, Mr. Anil Kumar Bohidar and Dr. C.V. Raje are declared elected unopposed as Vice President South East Zone and Vice President South Zone respectively.
- 9. So far as the post of Vice President, West Zone is concerned. there is one post. Tow nomination papers are found to be

- valid. As there are two candidates left in the field, polling for this post will have to be held on 25th September, 2016.
- 10. So far as the post of Vice President, North West Zone is concerned, there is only one post. Only one nomination paper has been found to be valid. Therefore, Mr. NarendhraKumar Nirwan is declared elected unopposed as Vice President North West Zone.
- 11. So far as the post of Vice President North East Zone is concerned, there is one post. Two nomination papers have been found to be valid i.e. Mr. Rajesh Bhandari and Dr. C.K. Jerath. As there are two candidates, polling for this post will have to be held on 25th September, 2016.
- 12. So far as the post of Vice President. Central Zone is concerned, there is only one valid nomination paper. Therefore, Mr. Anilkumar Mishra is declared elected unopposed as Vice President, Central Zone.
- So far as the post of Zonal Secretary, North East Zone is concerned, there is one post, but not a single nomination paper has been received. Therefore, the post remains vacant.

- 14. So far as the post of Zonal Secretary East Zone is concerned, two nomination papers were found to be valid. However, one candidate Mr. John Kharshiinghas withdrawn his nomination paper. Thus, only one candidate is left in the filed i.e. Mr. SwapanBanerjee, who is declared elected unopposed as Zonal Secretary, East Zone.
- 15. So far as the post of Zonal Secretary, South East Zone and South Zone are concerned, there is one post each. For each post only one candidate is left in the field and therefore, Mr. G.V. Ravi Raju and Mr. R. Gopu are declared as Zonal Secretaries for South East Zone and South Zone respectively.
- 16. So far as the post of Zonal Secretary, West Zone is concerned, there is only one post. Two nomination papers are found to be valid i.e. Mr. Rajesh Desai and Ms. PreetiBaria. Polling for this post is necessary and it will be held on 25th September, 2016.
- 17. So far as the Zonal Secretary, North West Zone is concerned, there is one post. Two nomination paperswere found to be valid. One candidate i.e. Mr. RejeshTokas has withdrawn his nominate paper leaving only one candidate in the field and

therefore, Mr. Digvijay Singh is declared unopposed as Zonal Secretary, North West Zone.

- 18. So far as the Zonal Secretary, North Zone is concerned, two nomination papers were found to be valid. One validly nominated candidate i.e. Mr.Nirmolak Sing has withdrawn his nomination paper and consequently, the other validly nominated candidateMr. Santosh Kumar Dutta is declared elected unopposed as Zonal Secretary, North Zone.
- 19. So far as Zonal Secretary. Central Zone is concerned, there is only one post. Only one nomination paper wasfound to be valid and therefore, Mr. Rajiv Kumar Singh is declared elected unopposed as Zonal Secretary Central Zone.
- 20. As a consequence of the withdrawal of the nomination papers, now on 25th September, 2016, voting will have to be held only for the following five posts:
 - President for which two candidates are contesting;
 - ii. Secretary General, for which three are candidates are contesting;
 - iii. Vice President, West Zone, for which two candidates are contesting;
 - iv. Vice President, North Zone, for which two candidates are contesting; and

- v. Zonal Secretary, West Zone for which two candidates are contesting.
- Following candidates are declared elected unopposed for the post mentioned against their names
