Minutes of Meeting Held on 22.08.2019 at BFI office in regards to the finalisation of 'Road Map for Tokyo Olympics'

The agenda of this meeting was to firm up the process of selection of boxers for 2020 Olympics and also to make the system objective and transparent. Along with the above main objectives some other aspects relating to the management of coaching camps were also discussed.

The followings are the gist of discussions and decisions taken in the meeting :

Selection criteria 'Elite Men' for Olympics:

1. **First Olympic Qualifier:**
 - a) The medallist of AIBA World Championship 2019 will be sent directly to the first Olympic qualifier to be held in China.
 - b) For the weight categories in which the boxers could not get a medal in the above championship, there will be selection trial amongst top 4 boxers as per participation criteria mentioned below on 29/30, November, 2019 at Patiala.
 - i. Participant of AIBA WC
 - ii. Gold Medallist of National Championship

- iii. Silver Medallist of National Championship
 - iv. Top boxer selected by the Coaches and Selection Committee based on recent National and International performances as well as performance in camp.
- Boxers who fail to complete 85% of the training at National Coaching Camp NCC, Patiala may not be considered for Trials.
 - There will be a seeding for each category as suggested by Foreign Coach and Head Coach in consultation with Selection Committee.
 - No changes in weight category will be entertained for the first qualifier. For the second qualifier, they can change in weight category prior to India Open and have to play in the revised weight category.

2. **Second Olympics Qualifier:**

- a) The 2nd qualifier will be in May, 2020 for those weights where we have not yet qualified. Prior to that there will be India Open in March, 2020. The best performer at India Open will be selected. In case, the scenario is not clear, then there will be trials amongst top 2 boxers of India Open as selected by Head Coaches and Selection Committee. These Trials will be held around 30th March, 2020.

Selection criteria 'Elite Women' for Olympics:

1. First Olympics Qualifier:

- a) The Gold/Silver medallist of AIBA World Championship 2019 will be sent directly to the first Olympic qualifier to be held in China.
- b) In case of weight categories in which there is no medallist in AIBA WCH, there will be selection trial amongst top 4 boxers as per participant criteria mentioned below between 27th Dec 2019 to 2nd Jan 2020 at Bellary / Delhi.
 - i. Participant of AIBA WC
 - ii. Gold Medallist of National Championship
 - iii. Silver Medallist of National Championship
 - iv. Top boxer selected by the Coaches and Selection Committee
- The Elite Women's National Championship will be held in December, 2019. (Tentative Dates 1st Dec to 7th Dec 2019.)
- There will be a seeding for each category as suggested by Foreign Coach and Head Coach in consultation with Selection Committee.

2. Second Olympics Qualifier:

- a) The 2nd qualifier will be in May, 2020 for those weights where we have not yet qualified. Prior to that there will be India Open in March, 2020. The best performer at India Open will be selected. In case the scenario is not clear, then there will be trials amongst top 2 boxers of India Open, selected by Head Coaches and Selection Committee. Selection Trials will be held around 3rd-4th April 2020.
- b) The participants of ASBC Under-22 participants will be exempted from National Championship and get lateral entry into the camp. Ranking in the camp will be decided on the basis of performance in the camp.
- c) No changes in weight category will be entertained for the first qualifier. For the second qualifier, they can have change in weight category prior to India Open and have to play in the revised weight category.

**Selection Criteria for Second Qualifier expected to be held in
May, 2020 for Tokyo 2020 Olympic Games.**

The 2nd qualifier will be held from 13-20 May, 2020 for those weights in which we have not yet qualified. The best performer in the National Camp will be selected. Following criteria will be taken into account for selection:

Elite Men

- International results from 2019 onwards with special emphasis on results since the current camp started on 15th November 2019. The performance takes into account the level of the opposition more than eventual medal won.
- Last Selection Trials held from 29-30 December.
- Performance in camp; including attendance record, sparring record and recent injury history.
- For clear understanding every boxer's position, the current National ranking will be updated right after Asian/Oceanian Qualifier finishes on 11th March, 2020.


In case, the scenario is not clear, then there will be trials amongst top 2 ranked boxers as selected by Head Coaches and Selection Committee, following the same criteria as above. These Trials will be held around 20th March, 2020.

Elite Women

- International results from 2019 onwards with special emphasis on results since the current camp started on 15th December 2019. The performance will be taking into account the level of the opposition more than eventual medal won.
- Last Selection Trials held on from 27 & 28 December, 2019.
- Performance in camp; including attendance record, sparring record and recent injury history.
- For clear understanding of every boxer's position, the current National ranking will be updated right after Asian/Oceanian Qualifier that finishes on 11th March 2020.

In case, the scenario is not clear, then there will be a Selection Trials amongst top 2 ranked boxers as selected by Head Coaches and Selection Committee, following the same criteria as above. These Selection Trials will be held around 28 March 2020 or 04 April 2020 as found suitable.
