DISCIPLINE & CATEGORY - Boxing (Elite Women)

The Administrative sanction of the Competent Authority is hereby conveyed for the conduct of National Coaching Camp for Elite Women Boxing Team with 30 Campers in two batches 21 campers (13 Boxers + 5 Coaches+ 3 Supporting Staff) in 1st batch which will start from 30th December, 2020 & 9 Campers (08 Boxers + 01 Coach) in 2nd batch, which will start from 07th January, 2021 at IG Stadium, New Delhi till 15th February 2021 respectively in preparation of Asian Championship– 2021"(as per list enclosed). The terms & Condition as follows: -

- 1. Boarding & Supplementary:
 - a. Boarding as per norms per head.
 - b. Supplements of Rs. 750/- (For above 70Kg Athletes) & Rs. 430/- (For Below 70Kg Athletes) per day per players to be provided by Boxing Federation of India on reimbursement basis.
- 2. Lodging as per norms per head.
- 3. Travel as per revised MYA&S norms.
- 4. Medical on actual.
- 5. The salary of the coaches approved in Panel should be paid on pro-rata basis as per norms and basis on the attendance verified by the coach in-charge and Administrator, IG Stadium to be paid through IG Stadium.
- 6. Please ensure that the revised SOP issued by SAI and MHA & State Government guidelines for COVID-19 is strictly adhered to. The undertaking of all athletes may be taken by IG Stadium, New Delhi in accordance with SAI SOP prior commencement of sports activity.
- 7. List of campers, coaches and support staff reported for the camp should be forwarded to TOPS Division on the 3rd day from the commencement of the camp.
- 8. Bio data of each camper may be sent on a Prescribed Performa.
- 9. On conclusion of the National Coaching Camp, Chief Coach in charge shall submit a comprehensive report of the coaching camp including performance of Asstt. Coaches, Supporting Staff through Regional Head within 15 days to TOPS Division.
- 10. It is mandatory for the Regional Head/Centre and the concerned Federation to submit Monthly Expenditure statement on last working day of the month and Utilization Certificate within 15 days of completion of the camp to the Finance Division with copy to TOPS-HPD Division.
- 11. The expenditure may be debited under the Head "General Assistance for holding Coaching Camp (Code No. 49.0500)
- 12. The monitoring of attendance on daily basis shall be maintained.
- 13. Issued Equipment to be verified & Stock entered in to register.
- 14. Scientific Support shall also be extended to the camper on request.

- 15. List of the campers & camp days is attached herewith.
- 16. Sports Kit to be issued once a year as per guidelines.
