- 1. Boarding & Supplementary:
  - a. Boarding @ Rs. 690 Only per day per head at IIS, Bellary.
  - b. Supplements of Rs. 750/. & Rs. 430/- (Weight Category Wise) per day per players to be provided by Boxing Federation of India on reimbursement basis.
- 2. Lodging up-to Rs. 1200/- per day per head.
- 3. FOP charges @Rs. 10,000/- per day to be booked at SAI HQ.
- Travel as per revised MYA&S norms, applicable as per senior category i.e 500 km or more by air economy class by shortest less than 500 km by 2<sup>nd</sup> AC train (for both way).
- 5. Medical on actual.
- 6. Please ensure that the revised SOP issued by SAI and MHA & State Government guidelines for COVID-19 is strictly adhered to. The undertaking of all athletes may be taken by IIS Bellary in accordance with SAI SOP prior commencement of sports activity.
- 7. List of campers, coaches and support staff reported for the camp should be forwarded to TOPS Division on the 3<sup>rd</sup> day from the commencement of the camp.
- 8. Bio data of each camper may be sent on a Prescribed Performa.
- 9. On conclusion of the National Coaching Camp, Chief Coach in charge shall submit a comprehensive report of the coaching camp including performance of Asstt. Coaches, Supporting Staff through Regional Head within 15 days to TOPS Division.
- 10. It is mandatory for the Regional Head/Centre and the concerned Federation to submit Monthly Expenditure statement on last working day of the month and

Utilization Certificate within 15 days of completion of the camp to the Finance Division with copy to TOPS Division.

- 11. The expenditure may be debited under the Head "General Assistance for holding Coaching Camp (Code No. 49.0500)
- 12. The monitoring of attendance on daily basis shall be maintained.
- 13. Issued Equipment to be verified & Stock entered in to register.
- 14. Scientific Support shall also be extended to the camper on request.
- 15. List of the campers & camp days is attached herewith.
- 16. Sports Kit to be issued once a year as per guidelines.
