In case any member is covered under the above act, he/she should obtain the prior permission from Ministry of Home Affairs before his/her departure to **Italy and Germany**.

Such of the Team Members who might be Central Government Servant are to be treated as on duty (which include deputation abroad) in respect of this participation by the Department/ Office in which they are employed in terms of Department of Personnel & Training O.M. No. 6/1/85-Estt. (Pay-I) dated 30.01.1989. The Federation should inform their employing Department/ Office accordingly.
