<b>Eligibility</b>	:	Boxers between the age of 17 and 18 according to their year of birth (1 <sup>st</sup> January, 2003 and 31 <sup>st</sup> December, 2004) are eligible to participate in the competition Entries will be accepted on receipt of Entry by Number & Entry by Name as per the enclosed format and duly signed by the President/Secretary of the affiliated unit of Boxing Federation of India.  All Boxers must have their Original birth Certificate & Medical Book. Photocopy of the original Birth Certificate must be produced at the time of weigh-in and Medical Examination.
<b>Medical &amp; Weigh-in</b>	:	Daily weigh-in and medical examination will be held at the venue daily from 0700-0800 hrs <b><u>ONLY</u></b> for the boxers drawn to box on those respective days from 18 <sup>th</sup> to 23 <sup>rd</sup> July, 2021. Boxer must present themselves without body piercing and accessories are allowed at the time of Medical, Weighing in & in bouts.
<b>Draw</b>	:	<b><u>Draw will be held on 17<sup>th</sup> July 2021 at 5:00 pm.</u></b>
<b>Dress</b>	:	Competitors shall Box in Boxing shoes or Shoes minus spikes and without heel, Shorts/Skirt not exceeding knee length and a Vest covering the chest and back. Boxers shall wear a Red & Blue Vest depending on the colour of the Corner. Where vests and Shorts are of the same colour, the Belt line must be clearly indicated by using an elastic waistband 10 Cm wide of White Colour. Women are permitted to wear sports hijab.
<b>Team officials</b>	:	The participating teams are entitled to bring two (2 ) coaches (Preferably Female), one (1) coach cum manager (Preferably Female) & 1 R/J (BFI 3 / 2 Star /AIBA Star) (Preferably Female), will be allowed per team.
<b>Boarding/Lodging</b>	:	Free Boarding and Lodging will be provided to all boxers and officials by the organizers from 17 <sup>th</sup> July to 24 <sup>th</sup> July, 2021 (before noon).
<b>Arrival particulars</b>	:	The Organizers will have their reception booth at Sonapat Railway Station & Bus Station. All team(s)/official(s) will be duly received on arrival upon receipt of prior intimation from the Units.
<b>Conveyance:</b>		Local conveyance from Railway Stations to their place of lodging and back will be provided by organizers. Transport will be available for participants and officials to and fro from place of stay to the venue of the championship.

**Important**

1. The Boxers and Officials are entitled to Railway Concession orders which will be sent through Courier / Speed Post/ mail.
2. To and Fro cost of travel to Sonapat and back of the Team / Officials will be the responsibility of respective units.
3. The Team / Officials shall not arrive at venue earlier than the 17<sup>th</sup> July, 2021 and shall leave by 24<sup>th</sup> July, 2021 by noon
4. Boxing Federation of India's 3 Star and / or 2 Star or AIBA Star Ring officials representing affiliated units must bring a nomination letter from their respective units President / Secretary intimating that they have been nominated as Ring official.
5. All boxers must possess their own Gum shield (not of red or partially red color) Red & Blue Vest & Shorts/Skirt according to their respective corner allocation.) Pubic protector or breast protector may be worn if needed.
6. The Boxer's weight should not exceed the maximum of the Boxer's weight class nor be below the minimum of the Boxer's weight class. However, for daily Weigh-in Boxer need to maintain his weight so as not to exceed upper limit of weight class.
7. No body piercing and body accessories are allowed to be worn during the bout and Medical Examination & Weighing In.
8. Women are permitted to wear sports hijab should they want to due to religious reasons.
9. Boxers must carry their Medical Record Book. They should also carry their original Municipal Birth Certificate or School Leaving Certificate (SLC) or Original copy of Age verified by the School on their letter head or Mark Sheet of 10<sup>th</sup> /12<sup>th</sup> standard for Boxing Federation of India's registration purpose, along with Aadhar Card.
10. **"Age Estimation Certificate"** for all participating Boxers conducted at a **Government Hospital as per SAI norms** is needed to be submitted during Medicals.
11. All boxers must carry a recent **Hepatitis B, C and HIV** test certificate.
12. All participating Boxers and RJ's also need to submit **Annual Medical Fitness Certificate** as per AIBA.
13. The Organizing Committee will provide Boxing gloves and Head Guards to all the Boxers for their respective bouts. Hand Bandages will be provided as well.
14. Adherence of strict discipline will be observed at the place of boarding/lodging and at the venue. Any breach of discipline will result in withdrawal of boarding and lodging arrangements, followed by disciplinary action.
15. The Championship will be conducted as per AIBA / BFI AOB Competition and Technical Rules.
16. Borrowing of boxers from any other unit, other than those approved by BFI is strictly prohibited.
17. Every team shall deposit Rs. 5,000/- as security deposit for accommodation and the same will be refunded after safe return of properties and facilities provided by the Organizer.
18. Persons accompanying the team as Manager and / or Coach will not be permitted to officiate as TO / RJ in the championship.
19. No extra member in the team will be allowed.
20. RT-PCR negative report is mandatory. All boxers, team official and technical official coming for the championship are requested to bring RT-PCR Negative report conducted within 96 hours. During the arrival at the championship temperature will be checked. If having temperature or does not possess negative RTPCR Report, he she will not be allowed to enter the venue.
21. It is Mandatory for everyone to use mask appropriately at all places, except in boxing ring. Covid appropriate behavior is expected from all.
22. Entry will be allowed ONLY to Boxers / Coaches / R&J's who have BFI Registration Number.
