Elite Women's Selection Trials

During the meeting, date and selection trial criteria of Elite Women World Championship was discussed and finalized. For this Championship, names are to be registered with IBA by the end of this month. Selection Trial for Women World Championship will be conducted in all 12 weight categories of IBA. The Selection Trials will be held amongst the National Campers and date of Selection Trial for Elite Women World Championship is finalized for 10th February to 12th February 2022 at I.G Stadium New Delhi. It is pertinent to mention that the National Camp for Elite Women has commenced from 11.12.2021 to 24.12.2021 and from 3.1.2022 to 15.3.2022.

The weight categories of Asian Games and Commonwealth Games similar to IBA Women World Championship which is 57kg, 60 kg and 75 kg will be selected from the World Championship Selection Trials which is on 10th Feb to 12th Feb 2022. For Remaining 2 weight categories 51kg and 69 kg a separate selection trial will be conducted from 14th Feb to 16th Feb 2022 at I.G Stadium New Delhi. In view of the Olympic Weight Categories that will be implemented in CWG and AG, as an exception, a boxer can change their weight category one weight up and one weight down only in 51 kg and 69 kg for Asian Games & Commonwealth Games Trials.

Elite Men's Selection Trials

The Elite Men Selection Trial is scheduled to be held in NSNIS Patiala from 10th Feb to 12th Feb 2022. Existing boxers of Elite Men National Coaching Camp will participate in the selection trials. The National Camps are now continuing from 11.12.2021 to 24.12.2021 and from 3.1.2022 to 15.3.2022.

World Championship for Elite Men Category has already been held. Therefore, during trials, Selection of Elite Men Boxers will be done for Asian Games, Commonwealth Games. The Weight Categories of Commonwealth Games and Asian Games with date of trial are as follows:

In view of the fact that the names are to be sent to Indian Olympic Association in this month, it is necessary that the trials are to be held now amongst the existing campers. Those who do not join the camp immediately will not be considered for the trial. In case selected boxers leave the camp without valid reason and without prior permission, then also the next boxer in the list will be considered.

In case due to any unforeseen situation, if the Championships are postponed or IOA intimates for review of the names giving extended date and if a substantial time has passed, BFI may consider to review this decision suitably.
