

Selection Policy for Youth Women & Youth Men Trials for IBA Youth Men & Women World Championship 2022

The following policy will be adopted for Selection Trials of Youth Women from 28th September to 2nd October 2022 at NCOE Bhopal, Madhya Pradesh and Youth Men from 1st to 2nd October 2022 at NCOE Guwahati, Assam

Youth Women Selection Trials

1. Youth Women Selection Trial will be held from 28th September to 2nd October 2022 at NCOE Bhopal in all 12 weight Categories.
2. The boxers of age group of 2004-2005 (i.e born between from 1st January, 2004 to 31st December, 2005) only are eligible.
3. Top three state/board of 5th Youth Women National Boxing Championship held at Chennai, from 6th July to 12th July 2022, i.e Haryana, Maharashtra and Delhi can nominate 4 Boxers in any of the 12 IBA weight categories.
4. Other State / UT / Boards can nominate a maximum of 2 Boxers from any of the 12 weight categories for the above said selection Trails.
5. Selection trial will be held in 2 Phases. First phase selection trial and Final phase selection trial.
6. First phase selection trials including national campers (From rank 2 to Rank 4) and boxer invited from state/board will compete from 28th to 30th September 2022. Gold medalist of Last Youth Women Championship held at Chennai will be exempted from First phase trial.
7. For Final selection trial, Gold medalist/Rank No 1 of the National Championship and winner of first phase trial (03 new boxers) will compete for final team selection on 1st & 2nd October.
8. Winner of the Final Selection Trial will be selected for IBA Youth Women World Championship. Rank no 2 Boxers will be the reserve boxer for IBA Youth Women World Championship.
9. The Ranking after final selection trial will be valid till December 2022.
10. Weight change for boxers will not be allowed.
11. All the bouts in selection trials will be video graphed.
12. This policy will be informed to all national medalists and will also upload to BFI website.

Youth Men Selection Trials

1. Youth Men Selection Trial will be held from 1st to 2nd October 2022 at NCOE Guwahati in all 13 weight categories.
2. All medalists (Gold, Silver, 3rd Bronze, and 4th Bronze) of 5th Youth Men National Boxing Championship held at Chennai will participate in the Selection Trial from 1st to 2nd October 2022.
3. Winner of the selection trial will be selected for the IBA Youth Men World Championship to be held from 14th November to 26th November 2022.
4. Rank no 2 Boxer will be the reserve boxer of IBA Youth Men World Championship 2022.
5. Ranking after the selection trial will be valid till December 2022.
6. Weight change for boxers will not be allowed.
7. All the bouts in selection trials will be video graphed.
8. This policy will be informed to all national medalists and will also upload to BFI website.
