Boxing Federation of India (BFI) is the National Federation for the sport of Boxing in India, recognized by the Government of India (Ministry of Youth Affairs & Sports, Department of Sports), the Indian Olympic Association and the International Boxing Association (IBA). Since its very inception, the BFI has made rapid strides for improvement of the sport of boxing focusing on the core development of the sport at grass root level. By strategic planning and professional management, the BFI has been able to make a mark in the international arena.

BFI would invite quotations to supply of Food Supplements to athletes in the National Coaching Camps as per details mentioned in annexure.

- a) The interested vendors are requested to submit their quotes in sealed envelope at BFI office by 2pm on 13th June, 2023.
- a) Supplies are to be made within 7 days of date of order.
- b) The bidder should not have been blacklisted during the last three years.
- c) The bidder should have all necessary clearances, if any required, from respective government agencies.
- d) The bidder should have all required statutory documents in respect of registration of company/organization with the government agencies, income tax, GST registration and clearances that the bidder should not have been defaulter on any account.
- e) Decision of BFI in respect of the above matter will be final. There will be no appeal against the decision of the BFI. The orders can also be split amongst bidders.
- f) More than one bidder may be selected/empaneled, if need be, subject to the bidders agreeing to match the lowest cost.
- g) The bidder must indicate the brands or the name of manufacturer, the product of whom they will supply.
- h) All the quoted rates should be valid for at least one year.

Terms of Payment:

- a) After supply of the food supplement the Vendor will obtain receiving and stock entry certificate from respective center. Bills will be submitted at BFI office along with receiving and stock entry report.
- b) Payment will be made within 15-30 days of submission of documents above subject and to the satisfaction of the BFI.

Dispute resolution

- a) Before issue of supply order, there will be no dispute and the decision of BFI will be final.
- b) After issue of order, all disputes will be resolved amicably by mutual consultation.
- c) In case, still disputes remain, it will be decided by Arbitration and in such eventuality the Arbitrator will be appointed by the BFI.
- d) The Arbitration Proceedings will be carried on as per the provisions of Indian Arbitration Act and will be governed by laws of India.
- e) In case of litigation, it will be subject to the jurisdiction of the Courts of Delhi.

Savings

- a) BFI reserves the right to vary the terms and conditions, scope of work, mentioned above at any time for operational reasons without assigning any reason.
