

The team members may be advised to call on the Mission for exchange of view.
- 4. A report on the visit of the team along with its performance/achievement in the above event may please be sent to this Ministry/ SAI within 7 days of the return of the team to India along with some action photographs, if possible.

5. Before departure, a report on dope test of the team members may please be obtained from DG, NADA New Delhi.
