In case, any team member is covered under the above Act, he/she should obtain the prior permission from Ministry of Home Affairs before his/her departure to **Bangkok, Thailand**.
- Such of the team-members who might be Central Government Servants are to be treated as on duty (which include deputation abroad) in respect of this participation by the Department/Office in which they are employed in terms of Department of Personnel & Training O.M. No. 6/1/85-Estt. (Pay-I) dated

- 30.1.1989. The Federation should inform their employing Department/Office accordingly.

The team members may be advised to call on the Mission for exchange of view.
  4. A report on the visit of the team along with its performance/achievement in the above event may please be sent to this Ministry/ SAI within 7 days of the return of the team to India along with some action photographs, if possible.
  5. Before departure, a report on dope test of the team members may please be obtained from DG, NADA New Delhi.
