CIRCULAR

Basis various communications, discussions held during the Guwahati AGM and recent BFI EC meeting, following rules are formed to tackle Borrowing of Boxers issues as well as allow legal transfer system for meritorious boxers to participate and showcase their skills.

As mentioned in the last AGM, all Boxers / Coaches / Officials must register themselves through their BFI Member units to be on BFI database, to participate in BFI meets and events.

It was also discussed and reconfirmed in the last BFI Executive Council Meeting, that last minute / illegal Borrowing of Boxers will **NOT** be allowed at any of the BFI Open National Championships. (Elite, Youth, Junior & Sub Junior National Championships)

However, Boxers can avail Transfer under following conditions ...

For National Championships :

1. Incase any boxer wishes to take a transfer from one Unit to another, the boxer will have to take a NOC from the existing unit and a Letter of Acceptance from the new unit, copies of both will have to be submitted to BFI to enable the boxers Transfer.
2. The window for such transfer processes will be from 1st October till 30th November every year and all the necessary documents have to be submitted to BFI by 30th November so as for BFI to complete all the formalities till end December.
3. Once approved, the boxer will be allowed to play only for the new unit from January to December of the following year.
4. Such transfers will be from State/UT to State/UT only. Boxers employed with BFI affiliated Boards are not allowed to box for any other State / UT at BFI's Official National Championships (wherein BFI Members can field only one boxer in each weight category) nor are allowed to take any transfers to State / UT units, while still under the Boards employment to box at BFI's Official National Championships.
5. But all other boxers employed with any other Government departments or Pvt Organisations are free to register themselves with either the State/UT association where they are originally from or the state where he/she is employed, to participate in any BFI approved tournaments.
6. However, such boxers must participate in the respective unit's state championships or selection trial in order to not to deny any local boxer an opportunity to prove his/her skills and claim his/her rightful place in the team.
7. A boxer playing for any other unit or Board within this period may be subject to disciplinary action and sanctions.



8. Boxers can take another Transfer only during the ~~next~~ Transfer period. i.e next year.
9. Any additional transfers within the year, before the transfer window i.e due to change of job, or for educational purposes etc may be allowed on case to case basis by providing the authentic documents well in advance, atleast 45 days prior and not at the last minute, just before the Nationals or any other meet.

For other Boxing Meets :

10. For all other tournaments throughout the year, boxers are free to participate from anywhere. Except that the borrowing of Boxer - at last minute - is not allowed.
11. Board boxers can participate from other Teams for all other tournaments including National Games, Zonal Championships, Inter Zonal Nationals & other All India Open / Invitational Boxing meets.
12. Boards and States having more number of boxers can field two teams at All India Open or Invitational Boxing meets, wherever it is allowed.
