since he is not recognized as the President of Tripura Amateur Boxing Association by Tripura Olympic Association and Directorate of Youth Affairs and Sports, Tripura.

- **Mr. Asish Kumar Saha (Tripura Amateur Boxing Association)** – In addition to the above, Mr. Asish Kumar Saha is also found ineligible for violation of Boxing Federation of India notice dated 07.03.2025 and National Sports Development Code of India, 2011.
