BOXING FEDERATION OF INDIA (BFI) – ELECTIONS FOR THE TENURE 2025-29

Record of Proceedings for Scrutiny of nominations held from 11 am onwards on 18.03.2025 at Boxing Federation of India office at 319, Udyog Vihar, Phase 4, Gurugram, Haryana, 122015

As per the election schedule published on 12.03.2025 the Returning Officer (RO) came to above mentioned venue for Scrutiny of nomination which have been received during the specified period i.e. 14.03.2025 to 6 pm of 16.03.2025. Pursuant to the invite extended by instructions published on 13.03.2025, some of the candidates and representatives of some other candidates have joined the proceedings. The particulars of the persons who participated are given in the attendance sheet which is enclosed to this Record of Proceedings (RoP) as Annexure – A.

Though the time for the commencement of the proceedings was notified to be 11 am, since there was thin attendance, it was decided by the RO to wait. After wait till 11:45 am, the proceedings were formally taken up.

The RO had passed to detailed orders on 13.03.2025 and 15.03.2025, primarily to deal with certain representations having a bearing on the Electoral College List and also to consider the proper course of action arising out of a situation wherein both the President and the Secretary General of BFI had prepared different Electoral College Lists. The List prepared by the President BFI was found to be meriting, primacy to be given over the list prepared by the Secretary General, given the letter and spirit of the BFI rules and Model Sports Code. Thus it was concluded that the list prepared by the Secretary General could not be acted upon. Further it was concluded, in the context of grievances relating to Delhi Armature Boxing Association (DABA) which had been raised before the RO upon liberty been given to the aggrieved person by the High Court of Delhi, the President of BFI having consequently left the matter to that extent to be decided by the RO, that for inclusion in the Electoral College List, the nominee of the state unit had to be holding an elected position. Aside from this, the RO expressly recorded in the previous orders that the preparations and finalization of the Electoral College List was the domain exclusively of the President of BFI. The said previous orders date 13.03.2025 and 15.03.2025 shall be read as part of these proceedings.

Post the above-mentioned order and before scrutiny of nominations, a number of representations have been received by the RO, through email communications, most of them raising questions about inclusion of certain persons in the Electoral College List on the basis of which this electoral process is being conducted. A large number of the said email representations raised question about the validity of nomination of Dr C.K. Jarath whose name is included at serial no 9 in the list of Electoral College, being one of the two nominees from Chandigarh. From amongst the recreationists, only Mr. Rajesh Bhandari (Sl. No. 23 in the

Electoral College List) is personally present at the meeting. A similar representation has been received by two emails both dated 17.03.2025 received from Nand Kishore Associates respecting nominations of Mr. Sai Satish & Mr. Manje Gowda (Sl. No 26 & 27) in the Electoral College List from Karnataka. Further Mr. S. K. Chhetri whose earlier representation was delt with in order dated 15.03.2025 has reiterated his objections about Mr. Atul Agnihotri (Sl. No. 53 in the Electoral College List) likewise, Dr Roopak Debroy has sent another email on 16.03.2025 taking objection to exclusion of Nominees from Tripura from the Electoral College List. On similar lines are two emails both sent earlier this morning by Mr. Ananta Pratap Reddy questioning the inclusion of Mr. C Babu Rao & Mr. P Ravindera (Sl. No. 51 & 52 in the Electoral College List). On similar lines, Mr. Madhav Aggarwal, describing himself as authorized representative (AR) of Mr. Ajay Singh (Sl. No. 55 in the Electoral College List) has also sent an email some time before objecting to the inclusion of the name of Mr. Jeetendra Patel (Sl. No. 13 in the Electoral College List) on the ground he is not a validly elected member of Daman & Diu association, having seemingly been appointed by an email dated 15.01.2023 of the Secretary General by the State Unit, this, per him, having a bearing of the validity of two candidates viz. Mr. Rajesh Bhandari (Sl. No. 23 in the Electoral College List) & Mr. Dillip N. Bhrambhatt (SI. No 18 in the Electoral College List). Mr Madhav Aggarwal, AR is present at the meeting.

The reorientations who are present at the meeting have been heard and views of the others present have been ascertained. The representations have been examined but are found not meriting acceptance. The reasons have already been set out in the previous orders dated 13.03.2025 & 15.03.2025. The Electoral College List remains the domain of the President. It crystalized with the order dated 13.03.2025 and the issues raised subsequently are only repetitive and need not result in the issues being reopened. The representations are disposed of with these observations.

In compliance with directions of the RO the office has prepared a detailed list of the nominated candidates giving requisite particulars, including of the mode of presentations of the nominations and the time of receipt.

Upon perusal of the above-mentioned list prepared by the office, it is noted that two nomination papers have been submitted by Mr. Ajay Singh (Sl. No 55 in the Electoral College List), one by email delivered at 3:21pm & the other at 3:22pm on 16.03.2025. Though the Prosper in each is different, the Seconder is same i.e. Mr. Sai Satish (Sl. No. 27 in the Electoral College List). Since the rules do not permit to proposer/second more than one candidate for the same post the nomination papers of Mr. Ajay Singh for the post of President are rendered inoperative. No objection was raised against the candidature of Mr. Ajay Singh (Sl. No. 55 in the Electoral College List) for the post of President based on nomination papers received at 3:21pm 16.03;2025, which were found to be in order and thus accepted.

Mr. Hemanta Kumar Kalita (SI.No. 5 in the Electoral College List) has submitted nomination paper for the post of President. Objection to his candidature for the said post was raised by Mr, Madhav Aggarwal, AR on the ground that Mr. Kalita has served as the Secretary General, in the out going team for the period 2021-25 and had also served in the immediately preceding term of 2016-2020 as the Treasurer for BFI. Reliance was placed on restrictions against a third consecutive term as per communication dated 01.05.2010 of Ministry of Youth Affairs and Sports (GOI), as per annexure XIII to the National Sports Development Code of India, 2011, and particularly on rule on "OFFICE BEARERES", forming part of the BFI rules reading thus (quoted to the extent necessary)

"The President can hold the office for a maximum period of three (3(terms of four (4) years each or twelve years with or without a break between terms.

The Secretary General and the Treasurer can serve a maximum of two (2) successive terms of four (4) years each, after which a minimum cooling off period of four (4) years will apply before either can seek fresh election for the posts of Secretary General and Treasurer.

However the Secretary General & Treasurer, on competition of two successive terms of four years each in either of the posts can contest for any post in the Executive Council, other than President, Secretary General and Treasurer."

Mr. Kalita himself is not present in the proceedings today but Mr. Rajesh Bhandari (Sl. No. 21 in the Electoral College List) is present on this behalf. He Fairley conceded the abovementioned factual position and effect of the above quoted rule. Indeed, Mr. Kalita having served 2 consecutive terms of 4 years each, one in the post of treasurer and the in the post of the Secretary General, he has to undergo a cooling off period for one term before he can offer his candidature for election to the post of President/Secretary General/Treasurer, the key words being "In either of the posts" in the above quoted rule. It is thus found that Mr. Kalita is ineligible to contest for the post of the President in the present election. His nomination papers were thus rejected.

Mr. Rajesh Bhandari (Sl. No. 21 in the Electoral College List) has submitted his nomination paper for the post of President. Mr. Madhav Aggarwal AR presses his objection on the ground Mr. Jeetendra Patel (Sl. No. 13 in the Electoral College List) who has proposed the candidature of Mr. Bhandari was incompetent to do so, he being not an elected member of the state unit of Daman & Diu. This objection is repackaging of the objection to the inclusion of Mr. Jeetendra Patel in the Electoral College List and, therefore, was found to be lacking substance. The objection was rejected. The nomination papers of Mr. Bhandari were found in order and thus accepted.

Mr. Pramod Kumar (SI.No 54 in the Electoral College List) has filled two nomination papers, both by email, one sent at 3:48pm & other at 3:49pm on 16.03.2025. There is no one present in the meeting raising any objection about his candidature. It is however noted that both nomination papers have been Seconded by Mr. Gopal Singh Kholia (SI. No. 56 in the Electoral College List). The second nomination paper deliver at 3:49pm on 16.03.2025 thus found to be inoperative. By emails dated 18.03.2025 an entity named Indian Generalists Association has reiterated questions about the credibility of Mr. Pramod Kumar based on certain materials implying past involvement in acts of commissions/omissions rendering him disqualified. Mr. Pramod Kumar was present in the meeting and stated that all such allegations are unfounded. No credible information or material has been submitted by any of the contesting candidates or their behalf. Hence the representations through emails is found to be not actionable material. The nomination papers of Mr. Pramod Kumar were found in order and thus accepted.

It is noted that Mr. Satish N (Sl. No. 27 in the Electoral College List) has filled nomination papers for the post of Secretary General, his name having been Seconded by Mr. Dhirendra Singh (Sl. No. 45 in the Electoral College List). Since Mr. Dhirendra Singh is the Proposer of the Candidature of Mr. Pramod Kumar (Sl. No. 54 in the Electoral College List) for the post of Secretary General, the endorsement by him of the candidature of Mr. Satish N can't be accepted on account of restrictions under the rule. Therefore, the nomination paper of Mr. Satish N for the post of Secretary General was rejected.

Mr. Dilip N. Brahmbhatt has filled nomination papers for the post of Joint Secretary (West Zone). Objection has been raised by Mr. Madhav Aggarwal AR on the ground that Mr. Jeetendra Patel (Sl. No. 13 in the Electoral College List) has Seconded the nomination of Mr. Brahmbhatt but he himself was incompetent. Similar objection in the context of candidatiue of Mr. Rajesh Bhandari for the post of President has already been rejected. For the same reasons, this objection was also repelled. The nomination papers of Mr. Dilip N. Brahmbhatt were found in order and thus accepted.

In the midst of these proceedings, 5 emails were received from Mr. Tipun Panda sharing some material respecting some litigation involving Orissa Amateur Boxing Association. The communications do not indicate as to what is the effect of the said litigation. At this stage of the dictation of these proceedings, Mr. Madhav Aggarwal AR submitted that he has been instructed by Mr. Pramod Kumar (Sl. No. 54 in the Electoral College List) to say that in the pending civil suit an order of temporary injunction has been issued on 12.03.2025 on the application of plaintiff Mr. Braj Gopal Panda requiring written statement to be filled on 20.03.2025. The copy of the order which the civil court may have passed is not readily available. The objector himself is not present and neither Mr. Pramod Kumar nor his AR are able to throw more light. In absence of the court order, it's effect can't be understood. The

above facts are intended to question the candidature of Mr. Anil Kumar Bohidar (Sl. No 39 in the Electoral College List) who has filled nomination papers for the post of Secretary General and also for the post of Treasurer. Mr. Bohidar is present in the meeting. On being asked, he sated that he has no knowledge of any such litigation or court order, no summons or notice or order having been served on him till now. His nomination papers are other found to be in order. His nomination papers are accepted, subject to the court order, if any, being produced at the earliest by the objector, Mr. Bohidar being also called upon to state his position/response on urgent basis the time given for the purpose being till the date of publication of the final list date of publication 22.03.2025.

It was found that Mr. Pon Bhaskaran (Sl. No 49 in the Electoral College List) having submitted his nomination for the post of Treasurer has not mentioned his full address. The deficiency was found to be mere irregularity, the copy was passport and Aadhar Card have been submitted. This was found not a ground of rejection of his papers.

It was noted that M. Dhirendra Singh (SI. No. 45 in the Electoral College List), a candidate for the post of the Joint Secretary (North West Zone), Is a government servant (North Western railways) and has submitted No Objection Certificate from his controlling authority with his nomination papers. His papers were found in order and thus accepted.

All the other nomination papers were also checked and found to be in order and, thus, were accepted.

It was noted that some of the candidates have not submitted the physical copies of their respective nomination papers. The position is recorded in the office note column of the detailed list of nomination papers referred to earlier. This is not taken as the ground for rejection of the corresponding nominations. The concerned candidates, however must do the needful by the date of publication of final list. i.e. 22.03.2025.

Suitable notes have been added in the remark column, in the Detailed List Of Nominated Candidates mentioned earlier which has been signed by the RO and made part of this RoP, as Annexure - B.

These proceedings were concluded at 2:30 PM.

The Executive Director of BFI is requested to publish a copy of this on the official website of the BFI and also communicate to all concerned.
