Greetings from the Boxing Federation of India!

We are pleased to announce that the Boxing Federation of India will be conducting the Under-22 Age Category Selection Trials for Men and Women from 7th July to 11th July 2025, at ASI Pune, Maharashtra. The selected team will represent India at the U-22 Asian Boxing Championship 2025, scheduled to take place in Bangkok, Thailand, from 31st July to 11th August 2025. **Please find below the revised criteria for the selection trials:**

- 1. U-22 Men and Women Boxers aged between 19 to 21 years (born between 2004 to 2006) are eligible to compete in the selection trials. As per the prospectus of Asian U-22 Championship 2025.
- 2. The selection trial of Men will be held in all 10 weight categories: 47-50kg, 50-55kg, 55-60kg, 60-65kg, 65-70kg, 70-75kg, 75-80kg, 80-85kg, 85-90kg & +90kg.
- 3. For Women Selection trial will be held in all 10 weight categories: 45-48kg, 48-51kg, 51-54kg, 54-57kg, 57-60kg, 60-65kg, 65-70kg, 70-75kg, 75-80kg & +80kg.
- 4. The top 3 Units/Boards from the 8th Elite Men's National Boxing Championship held in Bareilly, Uttar Pradesh (6th January to 13th January 2025) and the 8th Elite Women's National Boxing Championship held in Greater Noida, Uttar Pradesh (20th to 27th March 2025) can nominate one boxer in each weight category.
- 5. Top 3 State/Board/Unit of 8th Elite Men Boxing Championship are SSCB, RSPB and AIPSCB.
- 6. The Top 3 State/Board/Unit of 8th Elite Women Boxing Championship are RSPB, Haryana and AIPSCB.
- 7. The State Units/Boards ranked 4th to 7th in the 8th Elite Men National Championship, namely Himachal Pradesh, Haryana, Uttarakhand, and Delhi, are permitted to nominate 4 boxers in any of the 10 weight categories.

- 8. The State Units/Boards ranked 4th to 7th in the 8th Elite Women National Championship, namely SSCB, Punjab, Chandigarh, and Uttar Pradesh, are permitted to nominate 4 boxers in any of the 10 weight categories.
- 9. Other states/UTs/boards may nominate up to 2 (two) boxers in any of the weight categories for both Men and Women.
- 10. Boxers from the ongoing Elite Men & Women National Coaching Camp at NSNIS Patiala, born between 2004 to 2006, are also eligible to participate in this selection trial.
- 11. Gold or Silver medallists (Only one, whomsoever has the highest medal who meet the age criteria) of the REC Youth Combined Talent Hunt held from 6th to 13th October 2024 are eligible to participate. If both boxers fall within the age criteria, preference will be given to the gold medallist. Weight category of the boxer for participation in selection trial will remain same.
- 12. Gold & Silver medallist of U-19 World Boxing Championship 2024 are eligible to participate in this selection trials.
- 13. The winners of the selection trials will be chosen to participate in the Asian U-22 Boxing Championship 2025, with the runners-up serving as reserve boxers.
- 14. Participants are requested to bring the following documents to the selection trials:
 - o Passport
 - Birth Certificate
 - o Aadhaar Card
 - o Medical Certificate
 - o HIV Test
 - o Hepatitis B and C Test
 - o Non-Pregnancy Certificate (for women)
 - Age Estimation
- 15. Rank 1 & Rank 2 boxers will be selected for U-22 Men and Women Coaching Camp from 12th July to 30th July 2025 for preparation of Asian U-22 Boxing Championship in ASI Pune. Due to paucity of time, selected boxers for the coaching camp will be retained after selection trials to start the camp.
- 16. The responsibility for boarding/lodging for selection trial, local transportation at ASI Pune and to-and-fro transportation from the participant's location to ASI Pune will lie with the respective State/UT/Board/Individual.

Please submit your entries by 5:00 PM on July 1st, 2025, to info@boxingfederation.in. Ensure that your nomination is on the official letterhead, signed and stamped by the President or Secretary of your Association/Board. Late entries will not be accepted.
