I am directed to convey the approval of the Competent Authority for holding the National Coaching Camp for U-19 Boys and Girls Boxers with a total strength of 88 campers (including 60 boxers and 28 coaches & support staff) at full cost to the Government, subject to the following financial terms and conditions. **The list of Campers is attached as Annexure -1**

- 1. Medical expenditure on actual basis, provided the said injury is not covered under Insurance. However Regional Centre may incurred the expenditure immediately and claimed the same amount from Insurance agency. Subsequently a separate record be maintained in such cases by the concern **RC Mumbai**.
- 2. List of campers reported for the camp should be forwarded to the TOPS Division immediately after 2nd day from the commencement of the camp.
- 3. Any inclusion/deletion of National Coaching Campers should not be entertained without prior approval of the TOPS Division.
- 4. On conclusion of the Coaching Camp Regional Centre shall submit a report on coaching camp within 10 days to the TOPS Division, New Delhi.
- 5. The **RC Mumbai** to make all the necessary arrangements as per approved norms/approved by Competent Authority, for the camp sanctioned.
- 6. The Expenditure may be debited under the head of Financial Assistance to NSFs.
- 7. Sports kit (if approved above) will be issued by concerned Regional Centre Mumbai once in a year as per norms, irrespective of number of the camps attended.
- 8. A 100% advance amount of Rs. Rs70,00,360/-Approx.may be released in favour of SAI RC Mumbai. Further, RC Mumbai may transfer the amount to SAI NCOE Aurangabad for making necessary arrangements for holding the Youth (U-19) Boys & Girls National Boxing Coaching Camp at SAI NCOE Aurangabad. The head of RC Mumbai should submit the monthly expenditure statement discipline and head wise on the last working day of the month and utilization certificate within 15 days after completion of the camp to the TOPS Division.
- 9. The Expenditure may be debited under the head 49.0000 (Assistance to NSFs) with subheads as follows:
 - i. Expenditure towards lodging, boarding, additional diet allowances, travel, and insurance ,consumables ,medical tests under the sub-head 49.0501 (Coaching Camp (Trainees))
 - ii. Expenditure towards sports kit for campers under the sub-head 49.0505 (Sports Kit for national campers)

- 10. The Bills /Account of the camp will be settled by Regional Centre Mumbai on receipt of expenditure statement along with utilization certificates in the prescribed form GFR -2017 (form 12-A) duly certified by Chartered Accountant firm empanelled with CAG and counter signed by authorized signatory of the concerned NSF.
- 11. This issues with the approval of Competent Authority.
