I am directed to refer to BFI proposal regarding the above-mentioned exposure and to convey the acceptance of the Government towards providing funding for participation of U-17 Boys & Girls Team in 3rd Belt & Road International Training Camp cum Competition scheduled to be held from 15th to 30th August 2025 in Xinjiang, China with a team strength of 59 members (40 Boxers + 12 Coaches + 06 Supporting Staff & 1 Refree Judge) as mentioned below with the guidelines issued by the MYA & S under the Scheme of Assistance to NSF letter dated 22nd May 2025 and all amendments thereafter. The list of Participants is enclosed as Annexure-1.

- 1. As per the provisions scheme, the admissible assistance would be provided to the above team members.
- 2. Section 9 of FC (R) Act, 1976, provides inter-alia that no Member of a legislature, office bearers of a political party, Judge, Government Servant or employee of any Corporation shall accept any foreign hospitality without prior permission of the Central Government. In case, any team member is covered under the above Act, he/she should obtain the prior permission from Ministry of Home Affairs before his/her departure to China.
- 3. Such of the team-members who might be Central Government Servants are to be treated as on duty (which include deputation abroad) in respect of this participation by the Department/Office in which they are employed in terms of Department of Personnel & Training O.M. No. 6/1/85-Estt. (Pay-I) dated 30.1.1989. The Federation should inform their employing Department/Office accordingly.
- 4. It is requested that High Commission/Embassy of India at China and organizers of the event may please be informed by fax/email of the travel plans and itinerary of the team for participation in the above event. The team members may be advised to call on the Mission for exchange of view.



- 5. A report on the visit of the team along with its performance/achievement in the above event may please be sent to this Ministry/ SAI within 7 days of the return of the team to India along with some action photographs, if possible.
- 6. Before departure, a report on dope test of the team members may please be obtained from DG, NADA New Delhi.
- 7. Travel Sector: Hometown/New Delhi China-New Delhi/Hometown.
- 8. This issues with the approval of Competent Authority.
