
INSTRUCTIONS FOR THE BFI ELECTIONS FOR THE TERM
2025-2029

1. Nomination papers shall be mandatorily submitted / filed in-person by the Candidate at the Office of Returning Officer at B-11, Kailash Colony, New Delhi - 110048 from 10:00 Am to 6:00 Pm or through email to the Ld. Returning Officer on robfi2025election@gmail.com. The last date and time for sending the nomination through email shall be by 2:00 PM on 11th August 2025.
2. The candidates sending their nominations through email must send scanned nomination paper, after the forms are duly signed by the proposer, seconder and candidate, on the email address robfi2025election@gmail.com. The nomination paper shall be duly accompanied by the valid ID proof self-attested of the candidate, proposer, and seconder.
3. The candidates are mandatorily required to file the Nomination paper in Form – 2.
4. Nomination for any post of Office Bearer or Members of Executive Council shall be proposed by one of the authorised representatives of the member unit(s) whose name is included in the Electoral College list in Form-I issued by the Chairman, Interim Committee BFI and also subscribed by one such representative as a seconder.
5. The scrutiny of Nomination shall take place on 13 August 2025 at the Office of Returning Officer at B-11, Kailash Colony, New Delhi - 110048 from 11:00 Am to 5:00 Pm.
6. Notice of withdrawal of candidature shall be submitted either by candidate himself/herself after duly signing in Form-5 or this form may be sent through a person duly authorized by him/her at the Office mentioned above latest by 6:00 PM on 17th August, 2025 or the duly filled and signed withdrawal form may be scanned and sent by mail to the Returning Officer in the email id robfi2025election@gmail.com within the stipulated date and time as mentioned in the Election Schedule.
