<b>Dates</b>	Arrival 30 <sup>th</sup> December, 2025 Morning, immediately followed by <b>sports entries check from 10:00am onwards</b>  30 <sup>th</sup> December 2025 <b>Draw @ 5:00 pm</b> 31 <sup>st</sup> December 2025 to 6 <sup>th</sup> January 2026 ( <b>Competition Days</b> ) 7 <sup>th</sup> January 2026 ( <b>Departure before noon</b> )

<b>Last date of Entry</b>	25 <sup>th</sup> Dec 2025 ( <b>Entry by Number</b> ) 27 <sup>th</sup> Dec 2025 ( <b>Entry by Name</b> )
<b>Entry Fee</b>	Rs. 1,000/- per team in cash to be paid to BFI's representative at the time of sports entry check for state units and for affiliated boards Rs. 3000/-.
<b>Weight Class</b>	A team consists of a max. of 10 numbers of boxers (45-48, 48-51, 51-54, 54-57, 57-60, 60-65, 65-70, 70-75, 75-80 and +80 Kgs.)  Not exceeding One Boxer in each weight class. No reserves will be allowed.
<b>Competition Format</b>	Three (3) rounds of three (3) minutes, One (1) minute rest between rounds. 10 points must scoring system shall be followed. Championship will be conducted as per World Boxing Technical & Competition Rules.
<b>Eligibility</b>	<b>Boxers born during the year 1st January, 1985 - 31st December, 2006 are eligible.</b> Entries will be accepted on receipt of Entry by Number & Entry by Name as per the enclosed format and duly signed by the President/Secretary of the affiliated unit of Boxing Federation of India.  All Boxers must have their <b>Original Birth Certificate, Aadhar card &amp; Record Book.</b> Photocopy of the original Birth Certificate and Aadhar card must be submitted at the time of Initial weigh-in and Medical Examination.
<b>Medical &amp; Weigh-in</b>	Daily weigh-in and medical examination will be held at the venue from 0700-0800 hrs. <u>for those boxers who are drawn to box on those respective days</u> from 31 <sup>st</sup> December 2025 to 6 <sup>th</sup> January 2026. Boxers must present themselves without any body piercing etc. and accessories are not allowed.

<b>Draw</b>	<b>Draw will be held on 30<sup>th</sup> December 2025 at 5:00 pm.</b>
<b>Team officials</b>	The participating teams are entitled to bring three (3) coaches. Referee & Judges will be deputed by ROC Commission of Boxing Federation of India.
<b>Dress</b>	Competitors shall Box in Boxing shoes or shoes minus spikes and without heel, Shorts not exceeding knee length and a Vest covering the chest and back. Boxers shall wear a Red & Blue Vest depending on the color of the Corner. Where vests and Shorts are of the same color, the Belt line must be clearly indicated by using an elastic waist band 10 Cm wide of contrasting color (White).
<b>Boarding/Lodging</b>	Free Lodging & Boarding will be provided to boxers and officials by the organizers from 30 <sup>th</sup> Dec 2025 to 7 <sup>th</sup> January 2026 before noon. <b>Accommodation will not be provided before 30<sup>th</sup> December 2025. Team official arriving on 29<sup>th</sup> December 2025, will need to arrange their own accommodation for that day.</b>
<b>Arrival particular</b>	All teams will be duly received on arrival at the respective Metro Station upon receipt of prior intimation from the states to the Local Organizing Committee only.  <b>LOC's contact particulars will be circulated for information of all participating teams and other officials conducting the Championship.</b>
<b>Conveyance</b>	Local Transport from Railway Station to their place of lodging and back will be provided by organizers. Transport will be available for participants and officials to and fro the place of stay to venue of the championship and back.

**Additional Guidelines**

1. Entry will be allowed ONLY to Boxers / Coaches, whose name are in Entry by Name by state association in the prescribed format. **BFI Registration number is mandatory for participation.**
2. To and Fro cost of travel to Greater Noida, Uttar Pradesh and back of the Team / Officials will be the responsibility of respective units.
3. The Team / Officials shall not arrive at venue earlier than the 30<sup>th</sup> Dec 2025 and shall leave by noon of 7<sup>th</sup> January 2026.
4. All boxers must possess their own Gum shield, Red and Blue vest & shorts or skirts according to their respective corner allocation. Pubic protector and breast protector may be worn if needed.
5. For the first Weigh-in, the Boxer's weight should not exceed the maximum of the Boxer's weight class nor below the minimum of the Boxer's weight class. However, for daily Weigh-in Boxer need to maintain his weight so as not to exceed upper limit of weight class.
6. Any types of body piercing and body accessories etc. are not allowed to be worn during the bout and Medical Examination & Weighing In.
7. Women are permitted to wear sports hijabs "should they want due to religious reasons" as per World Boxing guidelines.
8. Boxers must carry their Record Book. They should also carry their original Municipal Birth Certificate or College / Institute Leaving Certificate (SLC) or original copy of Age verified by the School/College or Mark Sheet of 10<sup>th</sup> /12<sup>th</sup> standard for Boxing Federation of India's registration purpose, along with their Aadhar Card.
9. All boxers must carry a recent Hepatitis B, C and HIV test certificate. (within 3 months validity)
10. All participating Boxers and RJ's also need to submit BFI's Medical Fitness Certificate. (1 month validity)
11. The Organizing Committee will provide Boxing gloves, head guards to all the Boxers for their respective bouts. Hand Bandages will be provided as well.
12. Adherence of strict discipline will be observed at the place of boarding/lodging and at the venue. Any breach of discipline will result in withdrawal of boarding and lodging arrangements, followed by disciplinary action.
13. The Championship will be conducted as per World Boxing / BFI Competition and Technical Rules.
14. Every team shall deposit Rs. 3,000/- as security deposit for accommodation and the same will be refunded after safe return of properties and facilities provided by the Organizer.
15. Borrowing of boxers from any other unit, other than those approved by BFI is strictly prohibited.
16. Persons accompanying the team as Coach will not be permitted to officiate as TO / RJ in the championship.
17. NOC letter dated 13<sup>th</sup> December 2023 is stand cancelled and no longer be applicable.
18. Boxer Transfer Policy of BFI as previously practiced, will remain valid and in effect.
19. **No extra member in the team will be allowed.**
