**Administrative Sanction No. FCC-01/2026-27**

**Subject: Assistance for Participation of the Indian Elite Men and Women Team in World Boxing Cup 2, China from 13th June to 22nd June 2026.**

I am directed to refer to the BFI proposal regarding the above-mentioned exposure and to convey the acceptance of the Government towards providing funding for participation of the Indian Elite Men and Women Boxing Team in World Boxing Cup 2, China consisting of a total team strength of 32 members (20 Boxers, 08 Coaches, and 04 Support Staff) in accordance with the guidelines issued by MYAS under the Scheme of Assistance to NSFs letter dated 22nd May 2025 and all amendments issued thereafter.

The name list and composition of the team will be shared later.

1. As per the provisions of the scheme, admissible assistance shall be provided to the team members.
2. Section 9 of the FC(R) Act, 1976 provides, inter-alia, that no Member of Legislature, office bearer of a political party, Judge, Government Servant, or employee of any Corporation shall accept any foreign hospitality without prior permission of the Central Government. In case any team member is covered under the above Act, he/she should obtain prior permission from the Ministry of Home Affairs before departure to China.
3. Such of the team members who might be Central Government Servants are to be treated as on duty (including deputation abroad) in respect of this participation by the Department/Office in which they are employed, in terms of Department of Personnel & Training O.M. No. 6/1/85-Estt. (Pay-I) dated 30.01.1989. The Federation should inform their employing Department/Office accordingly.
4. It is requested that the Embassy/High Commission of India in China and the organizers of the event may please be informed by email/fax regarding the travel plans and itinerary of the team for participation in the above event. The team members may also be advised to call on the Mission for exchange of views.
