Subject: Assistance for Participation of the Indian Elite Men and Women Team in GRAND PRIX USTI NAD LABEM 2026, CZECH REPUBLIC from 15th June to 21st June 2026.

I am directed to refer to the BFI proposal regarding the above-mentioned exposure and to convey the acceptance of the Government towards providing funding for participation of the Indian Elite Men and Women Boxing Team in in GRAND PRIX USTI NAD LABEM 2026, CZECH REPUBLIC consisting of a total team strength of 25 members (14 Boxers, 06 Coaches, 04 Support Staff and 1 R&J) in accordance with the guidelines issued by MYAS under the Scheme of Assistance to NSFs letter dated 22nd May 2025 and all amendments issued thereafter. List of Participants attached as Annexure-1.

1. As per the provisions of the scheme, admissible assistance shall be provided to the team members.
2. Section 9 of the FC(R) Act, 1976 provides, inter-alia, that no Member of Legislature, office bearer of a political party, Judge, Government Servant, or employee of any Corporation shall accept any foreign hospitality without prior permission of the Central Government. In case any team member is covered under the above Act, he/she should obtain prior permission from the Ministry of Home Affairs before departure to Czech Republic
3. Such of the team members who might be Central Government Servants are to be treated as on duty (including deputation abroad) in respect of this participation by the Department/Office in which they are employed, in terms of Department of Personnel & Training O.M. No. 6/1/85-Estt. (Pay-I) dated 30.01.1989. The Federation should inform their employing Department/Office accordingly.
4. It is requested that the Embassy/High Commission of India in Czech Republic and the organizers of the event may please be informed by email/fax regarding the travel plans and itinerary of the team for participation in the above event. The team members may also be advised to call on the Mission for exchange of views.
5. A report on the visit of the team along with its performance/achievement in the above event may please be submitted to this Ministry/SAI within 7 days of return of the team to India along with action photographs, if possible.

6. Before departure, a report regarding dope testing of the team members may please be obtained from DG, NADA, New Delhi.
7. Travel Sector: India Hometown– Prague – Hometown.
