Subject: Participation of Indian Elite Men & Women Boxing Team (Rank-3 Boxers) in the Golden Belt Tournament, Romania from 9th July to 18th July 2026

I am directed to refer to the proposal received from the Boxing Federation Of India (BFI) regarding the above-mentioned competition and to convey the acceptance of the Government towards providing assistance for participation of the the Indian Elite Men & Women Boxing Team (Rank-3 Boxers) in the Golden Belt Tournament, Romania from 9th July to 18th July 2026, consisting of a total contingent strength of 18 members team (10 Boxers, 04 Coaches , 02 Physiotherapists , 01 Doctor and 01 R&J list enclosed at Annexure-I) in accordance with the guidelines issued by MYAS under the Scheme of Assistance to NSFs vide letter dated 22nd May 2025 and all amendments issued thereafter.

1. As per the provisions of the Scheme, admissible assistance shall be provided to the team members.
2. Section 9 of the FC(R) Act, 1976 provides, inter alia, that no Member of Legislature, office bearer of a political party, Judge, Government Servant, or employee of any Corporation shall accept any foreign hospitality without prior permission of the Central Government. In case any team member is covered under the above Act, he/she should obtain prior permission from the Ministry of Home Affairs before departure to Bulgaria.
3. Such of the team members who might be Central Government Servants are to be treated as on duty (including deputation abroad) in respect of this participation by the Department/Office in which they are employed, in terms of Department of Personnel & Training O.M. No. 6/1/85-Estt. (Pay-I) dated 30.01.1989. The Federation should inform their employing Department/Office accordingly.
4. It is requested that the Embassy of India in Romania and the organizers of the event may please be informed by email regarding the travel plans and itinerary of the team for participation in the above event. The team members may also be advised to call on the Mission for exchange of views.



5. A report on the visit of the team along with its performance/achievement in the above event may please be submitted to SAI/TOPS Division within 7 days of return of the team to India along with action photographs, if possible.
6. Before departure, a report regarding dope testing of the team members may please be obtained from DG, NADA, New Delhi.
7. Travel Sector: DEL-OTP-DEL.
